

Town of Maxville
Regular Monthly Meeting Minutes
July 11, 2023

Dan Weisenbeck, Chairman, called the Regular Monthly Meeting of the Maxville Town Board of Supervisors to order at 6:00 PM, Tuesday, July 11th, 2023 at the Maxville Town Hall.

Roll Call/ Present: Chairman Dan Weisenbeck; Supervisor Bruce Kees; Supervisor Andy Hayden; Treasurer Carrie Lindstrom & Clerk Barb Traun.

Minutes/Treasurer's Report: Minutes of the June 13th, 2023 meeting were read and approved. Treasurer's report showed that Maxville has a balance of \$156,056.40 including a cemetery fund total of \$7,701.39 & ARPA funds of \$31,685.70 leaving available funds of \$148,355.01. Treasurer's report was approved as read & presented.

Citizen's Concerns: Bruce Kees reported that Bruce Martin had talked to him about his road/Woodpecker Lane. It is in bad shape. Sanitation dumpster pickup truck has caused damage along with neighboring fertilizing equipment/trucks. He asked about resurfacing/blacktopping it. Bruce Kees told him regrettably township doesn't get or have funds to blacktop smaller town road driveways.

-Dan had gotten a call from Lynette Wagenbach about Parrott Ln. Bruce did patch it and Lynette thanked township.

-Both Bruce & Dan had checked out Castleberg Rd. Because of Black's Valley Ag trucks parking there & pulling out, there is a drop off on the shoulder really close to the blacktop surface. Dan had talked to Don Black and told him to have their company haul breaker rock on the shoulder so the blacktop does not break off and get damaged. Dan told Don that Black's should pay for the rock because their trucks caused the erosion of the shoulder.

Correspondence/Announcements:

-There was discussion on the Buffalo County WTA Unit *Picnic* July 17th. Dan & Jane and Barb and Larry plan to attend and ride share.

Town Hall Update: Bruce reported that the County Recycling had been called a week early because the recycling bins were full and needed to be picked up/emptied.

Town Road Update:

-Dan asked about getting the town roads mowed. There was discussion. Dan will call Pepin County Highway Department and ask them to mow.

-Rock had been hauled on Swan and Crow Lanes.

-Bruce had gotten road patch and patched town roads. He will cut a big oak on Price Rd.

-Andy had cleared limbs off the town roads after the July 4th rain storm.

Pay Monthly Bill: Monthly bills were reviewed and payments made. See disbursement journal for details.
