

Town of Maxville
Regular Monthly Meeting Minutes
July 13, 2021

Dan Weisenbeck, Chairman, called the Regular Monthly Meeting of the Maxville Town Board of Supervisors to order at 6:00 PM, July 13th, 2021 at the Maxville Town Hall.

Roll Call/ Present: Chairman Dan Weisenbeck; Supervisor Bruce Kees; Supervisor Andy Hayden; Treasurer Carrie Lindstrom; Clerk Barb Traun and Jane Weisenbeck.

Minutes/Treasurer's Report: Minutes of the June 8th, 2021 meeting were read and approved as read. Treasurer's report showed that Maxville has a balance of \$322,503.02 including a cemetery fund total of \$5,855.92 with \$0.00 tax collections money leaving available funds of \$316,647.10.

Citizen's Concerns: Andy reported that hes gets complaints about our township "not" being open to ATV/UTV use. Neighboring township, Canton is signed. There was discussion. Maxville has notified Buffalo County. Signage is just not being done. Lots of frustration!

-Dan received a call from Nancy Hurlburt about overhanging limbs/trees out her driveway. She wondered if her son could cut them? Dan said of course, township would be grateful too.

Correspondence/Announcements:

-Dan reported the WTA Buffalo Co. Unit meeting/picnic will be Monday, July 19 at the Town of Cross Town Hall. After discussion, all who can attend will get back to Dan and meet at the Maxville Town Hall, Monday, July 19 to ride share. Durand Rural Fire Dept.'s quarterly meeting is Tuesday, July 20, 2021.

-Maxville applied and received the 1st installment of \$15,804.95 from the American Rescue Plan Act – it will be put in a separate account until it is spent.

-Dan had filled out the Multi-Hazard Surveys for the second time and mailed them this time.

-Bruce asked about the aluminum cans in the recycling shed. They are really piling up and should be taken somewhere. There was discussion. Carrie mentioned the person in Arkansas and Barb would get the # for the person located in Modena.

Town Hall Update: Adeline Hanson, Dan's granddaughter developed a website for the Town of Maxville. It is very nice: <https://townshipofmaxville.weebly.com/>. There was discussion on reimbursing her. Bruce Kees moved to pay Adeline \$200. Andy Hayden seconded. Vote was 3 ayes. Motion carried.

-Barb asked if we could sign an extra check for prepay LP from Schaul's if they send out letters. Board approved.

Town Road Update:

-Township has not gotten a corrected bill from Monarch. Dan will call them again.

-Bruce gave an update on roads he had patched and cut brush and put shale & rock on corners. He thinks he has enough blacktop to patch Finch, Johnson Hill, Price and one more town road. He reported about 2 incidents on Kings Hwy. Individual was not hurt. Just shoulder damage – no blacktop damage. It is being taken care of. Durand Coop had an incident. Bruce had called them.

-Dan will call Pepin County to see if they will mow township roads. Because of new construction/soft shoulders, town will "not" mow Kings and Golden roads.

-Barb asked about a bill for a culvert for Kent Hurlburt. Dan will call Kent about billing him.

-Dan reported Bob Platteter will work with us about the mistaken grader patching of Lindstrom Rd that the Hwy Dept did. Maxville can pay when able.
