

Town of Maxville
Regular Monthly Meeting Minutes
July 13, 2022

Dan Weisenbeck, Chairman, called the Regular Monthly Meeting of the Maxville Town Board of Supervisors to order at 6:00 PM, Wednesday, July 13th, 2022 at the Maxville Town Hall.

Roll Call/ Present: Chairman Dan Weisenbeck; Supervisor Bruce Kees; Supervisor Andy Hayden; Treasurer Carrie Lindstrom & granddaughter; Clerk Barb Traun and Jane Weisenbeck.

Minutes/Treasurer's Report: Minutes of the June 14th, 2022 meeting were read. Treasurer's report showed that Maxville has a balance of \$155,755.84 including a cemetery fund total of \$7,075.28 & ARPA funds of \$15,827.50 leaving available funds of \$148,680.56. Minutes and Treasurer's report were approved as read & presented.

Citizen's Concerns: Diane Weisenbeck called about the county mowing on Cty Rd. F. There is so much wild parsnip going to seed. She had called/emailed the Buffalo Hwy Commissioner and Barb gave her the County Board member's name, Brad Schmidtknecht.
-Bruce was also asked about mowing & brushing on Johnson Hill Road.

Correspondence/Announcements: Dan had gotten plastic containers/barrels for the cemetery. Old ones are still there. Bruce will take care of them
-There was discussion on the Buffalo County WTA Unit *Picnic* July 18th. Those able to attend should meet at the town hall at 5:00 pm to ride share with Dan.
-Barb asked about having 4 election workers for the August 9th, Partisan Primary. Board all agreed it was okay. She will have a training first week of August after the Public Test for the 4 workers.

Town Hall Update: There was discussion on the aluminum cans at the recycling shed. After discussion, Bruce will do a trial run to the place on Hwy 312 to see if it is cost effective. If it is not – we will put the cans in the recyclable dumpster for the county pickup.

Town Road Update:

-Dan reported Pepin County Hwy Dept. will mow town roads the end of July. He also had talked to Canton Chairman, Tony Poeschel about their patrolman brushing. There was discussion. Bruce will call Jim Bignell and have him look at Johnson Hill Rd and Thibodeau,
-Bruce reported he had done work on Spring Creek Rd by Warren Zastrow's, on Price Rd and by Jemilo's on Kings Hwy and on Johnson Hill Rd. He also mentioned Kent Hurlburt reported a badger had caused damage on Stai Coulee Rd by the potato shed.
